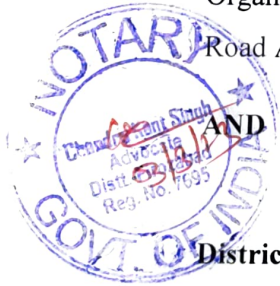

J.S. University, Shikohabad, 5 Km Milestone, Mainpuri Road Shikohabad District Firozabad Uttar Pradesh Pin Code 283135 an Educational Institution approved by University Grants Commission (UGC) and AICTE, represented herein by its Director General, Dr. Gaurav Yadav on the other part

Here in after collectively also referred to as "parties" and individually as "party"

It is effective upon signing and shall remain in effect for a period of **One year** or until termination by either party with 30 days written notice whichever is earlier. This agreement may also be extended/modified at the end of the third year after review and need is felt for extension of the agreement.

This memorandum of understanding is designed to reflect the understanding between **J.S. WHEREAS,

NOW THIS MEMORANDUM OF UNDERSTANDING WITNESSETH AS FOLLOWS:-

- **Scope: Area and Method of Co-operation.**

The area of Co-operation includes any programme offered by either of the participating parties determined to be desirable and feasible for developing co-operative relationships. The methods of co-operation include, subject to availability of funds and the approval of each institution, research, training and academic activities or programmes such as:-

- Joint training courses, graduate and undergraduate student mobility such as internships, exchange and fellowships.
- Participation in and co-hosting of lectures, meetings, seminars, symposia and conferences.
- Exchange of materials, publications and other information, within limits of legal rules and regulations.
- Collaboration in other areas that foster research training and educational co-operation.



Terms of each activity or program including budget for each program and activity, shall be discussed and agreed upon in writing by both parties prior to the initiation of the particular program or activity. All terms shall be negotiated on a mutual basis and documented in a project or program agreement. Such joint programs and resulting agreements shall specify the specific responsibilities and obligations of each party.

- **Intellectual Property**

Procedures for the handling of intellectual property rights that may arise during the course of this collaboration shall be outlined in a separate document. All terms shall be negotiated on a mutual basis prior to the start of the collaborative project in questions and in accordance with the policies of each institution.

- **Principles**

Implementation of this MOU will be in accordance with the Policies on co-operation of the MSME-Technology Development Centre, Agra and relevant policies at the **J.S. University, Shikohabad, 5 Km Milestone, Mainpuri Road Shikohabad District Firozabad Uttar Pradesh Pin Code 283135** Participants under this MOU will be selected on the basis of merit without regard to race, national or ethnic origin, color, religion, age sex, sexual orientation, marital status or physical handicap and will each accept the participants selected by the other party if mutually acceptable academic and/or professional qualifications and standards are met. All participants will be treated in the same non-discriminatory manner in carrying out the provisions of the MOU, subject to the provisions of the policies and requirements of each of the institutions. Any violation of these Principles will be considered grounds for terminating this MOU.

- **Terms of Co-operation**

- **Length of Agreement**

This Memorandum of Understanding will remain in force for a period of one year.

Visiting participants will be responsible for obtaining the necessary insurance coverage including but not limited to travel and comprehensive medical insurance coverage. The host institution cannot be responsible for any damages suffered or caused by a visiting participants.

Visiting participants will abide by the institutional policies, procedures and regulations by which the host party abides and by the local laws.

- **Amendments**

Any amendment to the Memorandum of Understanding will require written approval of each of the party. After the initial one year period, this Memorandum of Understanding may be renewed by mutual consent.

- **Termination**



Either party reserves the right to terminate this Memorandum of Understanding upon 30 days written notice. Any program or activity that has already commenced shall be completed to the best of both parties' abilities.

- **Language**

This agreement is created in duplicates in English, each of those duplicates being deemed original.

- **Signature**

Two signed originals of this Memorandum of Understanding will be produced, one to reside with each party.

This MOU shall not create any legal obligation on either party and a separate agreement shall be entered into between the parties of this MOU in respect of execution of the work agreed under this MOU.

Service audit and program review functions shall be performed jointly when appropriate. Both parties mutually agree not to use the name of the other party in any public information without permission of the concerned party.

Duration of course: Duration of course will be as per the guidelines (depend as per the course).

Certificate Details: Course certificate will be provided by MSME Technology Development Centre (PPDC), Agra to the students who will successfully complete the course with 80% attendance and pass the examination to be conducted at the completion of the course.

Fees structure will be decided by the management of both institutions.

The above MOU is valid for one year from the date of signing.
