

MEMORANDUM OF UNDERSTANDING (MOU)

Between

Nordek Lab Technology LLC (Location: Dubai, UAE) ("First Party")

And

J S University (Location: Shikohabad, India) ("Second Party")

1. Purpose

The purpose of this Memorandum of Understanding (MOU) is to establish a collaborative agreement under which Nordek will conduct a "Nordek Genesis Tech Workshop" at J S University to introduce Blockchain and Web3 technologies to the students.

2. Scope of Work

Nordek agrees to provide the following services:

- 1. Development and delivery of a workshop tailored to introduce and explain Blockchain and Web3 technologies.
- 2. Provision of qualified speakers to conduct the workshop.
- 3. Supply of necessary educational materials and resources for the workshop attendees.
- 4. Showcase various opportunities for students including, but not limited to, a campus ambassador program, a 'Build with us' program, and other career opportunities that may arise from Nordek's line of work.
- 5. Engage with students to explore potential collaborations and pathways in blockchain technology careers post the workshop eg. hackathons and bootcamps.

J S University agrees to:

- 1. Provide suitable facilities for the conduct of the workshop.
- 2. Facilitate the participation of students in the workshop.
- 3. Provide necessary support staff and logistics required during the workshop.
- 4. Provide a designated Point of Contact (POC) for Nordek to assist in the coordination of the workshop and to facilitate communication apart from ensuring that the POC will also be responsible for any additional mutually agreed upon tasks like assisting with specific tasks such as photography and videography of the sessions.

Both parties agree to:

 Explore future engagement opportunities that may include the creation of a centre of excellence in blockchain technology, advanced student training, and other collaborative educational initiatives.

Engage in discussions to mutually agree upon the scope, nature, and financial aspects of any such future engagements, which will be documented in separate agreements as appropriate.

3. Duration

The workshop shall be conducted on the campus virtually with an agreed duration.

4. Financial Arrangements

Nordek agrees to provide the "Nordek Genesis Tech Workshop" free of charge to the students of J S University. No fees will be levied on the students for attending this workshop. There will be no cost incurred by the two parties for hosting this workshop. Financial arrangement of any future engagement apart from the tech workshop will be mutually agreed.

5. Intellectual Property

Any intellectual property rights arising from the workshop materials will remain the property of Nordek, unless otherwise agreed upon in writing.

6. Confidentiality

Both parties agree to maintain the confidentiality of any proprietary information shared during the workshop.

7. Liability

Each party shall be responsible for its own actions and results thereof and shall not be liable for any indirect damages or losses caused to the other party.

8. Termination

This MOU may be terminated by either party with written notice in advance.

9. Legal Compliance

Both parties affirm that they will adhere to all relevant laws and regulations in the execution of this MOU.

10. Dispute Resolution

Any disputes arising from this MOU will be resolved through negotiation and mutual agreement.

11. Signatures

This MOU is not legally binding but serves as a statement of intent between the parties.
